# **Appendix I: Action on Women's Health Legislation in the 106<sup>th</sup> Congress**

Abortifacients: FY2000 agriculture appropriations conferees dropped a House-passed provision that would have prohibited the Food and Drug Administration (FDA) from using funds to test, develop, or approve drugs that may chemically induce abortions (September 1999). A similar amendment was defeated by the House during consideration of the FY2001 agriculture spending bill (July 2000).

Subsequently, the FDA approved an abortifacient known as RU-486 in September 2000. Although legislation (H.R. 5385/S. 3157) aimed at curtailing distribution of the drug was introduced late in the second session, no action occurred on the measure.

**Abortion Restrictions:** As it has for two decades, the annual appropriations process served as the primary congressional battleground on abortion. The 106th Congress renewed existing restrictions on the use of federal funds—and, in the case of the District of Columbia, local funds—to pay for abortions for the following groups of women:

- federal workers and their dependents under the Federal Employees Health Benefits Program (FY2000 and 2001 Treasury-Postal Service appropriations);
- Peace Corps volunteers (FY2000 and 2001 foreign operations appropriations);
- low-income women in the District of Columbia served by Medicaid (FY2000 and 2001 District of Columbia appropriations); and
- women in federal prisons (FY2000 and 2001 Commerce-Justice-State appropriations).

Abstinence Education: The FY2000 emergency supplemental appropriations included \$20 million for abstinence education programs under the Maternal and Child Health Bureau (July 2000). The emergency funding was included in the FY2001 military construction spending bill. The FY2001 Labor, Health and Human Services, and Education spending bill appropriated \$30 million in advance FY2002 funding for these programs (December 2000). Additionally, as required by the 1996 welfare reform law (P.L. 104-193), \$50 million was appropriated in each of FY2000 and FY2001 for abstinence education programs administered by the Ado-

lescent Family Life Act (November 1999/December 2000).

**Agency for Healthcare Research and Quality** (AHRQ) Reauthorization: Congress approved legislation (H.R. 2506/S. 580) to reauthorize and revamp AHRQ (November 1999).

Autoimmune Diseases: Congress approved legislation to require the Director of the National Institutes of Health to expand, intensify, and coordinate research on autoimmune diseases at the NIH (October 2000). The provision was included in a bill (H.R. 4365) to reauthorize and extend children's health research programs at the NIH.

Bankruptcy Reform/Abortion Clinic Violence: Conferees for a bill (H.R. 833) to reform bankruptcy laws dropped a Senate-passed provision that would have prohibited the discharge of debt resulting from a conviction under the Freedom of Access to Clinic Entrances Act (November 2000).

**Biomedical Imaging:** Congress approved legislation (H.R. 1795) to create a National Institute of Biomedical Imaging and Bioengineering at the National Institutes of Health (December 2000).

Born Alive Infants Protection Act: The House approved legislation (H.R. 4292) that would have changed the definition of an individual under the U.S. Criminal Code (September 2000). The Senate attempted to consider the House-passed bill under a unanimous consent agreement, but a Senator objected (October 2000).

**Breast Cancer Research:** Congress approved legislation to appropriate \$175 million for peer-reviewed breast cancer research at the Department of Defense in FY2000 and FY2001 (October 1999/August 2000).

Congress also approved legislation (H.R. 1654) to reauthorize the National Aeronautics and Space Administration. The bill includes \$2 million for research and early detection systems for breast and ovarian cancer and other women's health issues (September 2000).

**Breast Cancer Stamp:** Congress approved legislation (H.R. 4437) to reauthorize the sale of special "semipostal" U.S. postage stamps to raise money for breast cancer research (July 2000).

The Senate also approved similar legislation (S. 2386); however, the Senate-passed bill would have ensured that the U.S. Postal Service was reimbursed for the full cost of producing the semipostal stamp (July 2000).

Breast and Cervical Cancer Treatment: Congress approved legislation (H.R. 4386) to give states the option of providing treatment under Medicaid for women diagnosed with breast or cervical cancer through the Centers for Disease Control and Prevention's National Breast and Cervical Cancer Early Detection Program (October 2000).

**Breastfeeding:** Congress approved legislation allowing women to breastfeed on federal property. The provision was included in the FY2000 and 2001 Treasury-Postal Service appropriations bills (September 1999/December 2000).

Child Custody Protection Act: The House passed a bill (H.R. 1218) that would have made it illegal for anyone but a parent to transport a minor across states lines to obtain an abortion and evade the home state's parental consent law (June 1999). The Senate did not consider a similar measure.

Clinical Lab Tests: Congress approved legislation to make the national limitation amount for new clinical laboratory tests, including Pap tests, equal to 100 percent of the national median for such tests (December 2000). The provision was included in the FY2001 Consolidated Appropriations Act.

Collective Bargaining: The House approved legislation (H.R. 1304) that would have allowed health care providers to collectively bargain with health insurers (June 2000). The bill included a provision that would have prevented doctors from including abortion coverage among the services for which they could collectively bargain with health insurers. A similar bill was not considered by the Senate.

**Contraceptive Coverage:** Congress approved legislation to extend current law by requiring health plans

participating in the Federal Employees Health Benefits Program to cover prescription contraceptives if they also cover other prescription drugs. The provision was included in the FY2000 and 2001 Treasury-Postal Service appropriations bill (September 1999/December 2000).

**Date Rape Drugs:** Congress approved legislation (H.R. 2130/S. 1561) placing Gamma Hydroxybutyrate (GHB), a drug commonly used to facilitate date rapes, on Schedule I of the Controlled Substances Act (February 2000).

**Domestic Violence/Insurance Discrimination:** Congress approved legislation (H.R. 10/S. 900) to overhaul the financial services industry. The final version includes a provision to prohibit banks from using domestic violence as a criterion for underwriting health and life insurance policies (November 1999).

**Domestic Violence in the Military:** Congress approved legislation establishing a Defense Task Force on Domestic Violence and requiring the Secretary of Defense to issue regulations on Armed Forces policies relating to confidentiality of communications between a patient and a doctor with respect to sexual harassment, assault, or domestic violence. The provisions were included in the FY2000 defense authorization bill (September 1999).

**Domestic Violence Stamp:** Conferees on the FY2001 Treasury-Postal Service appropriations bill dropped a Senate-passed provision that would have authorized the creation of a U.S. semipostal stamp to raise money for domestic violence programs at the Department of Justice (October 2000).

**Embryo Research Ban:** Congress approved the FY2000 and 2001 Labor, Health, and Human Services, and Education appropriations bills with a restriction prohibiting the use of federal funds for embryo research (November 1999/December 2000).

Emergency Contraception: Conferees on the FY2001 Labor, Health and Human Services, and Education appropriations bill dropped a Senate-passed provision that would have prohibited the distribution of emergency contraception in schools (December 2000).

Family Caregivers: Congress approved legislation

authorizing \$125 million for the establishment of a new National Family Caregivers Support initiative. The program was included in the reauthorization of the Older Americans Act (H.R. 782) (November 2000). The FY2001 Labor, Health and Human Services, and Education spending bill appropriated \$125 million for the program in FY2001 (December 2000).

Female Genital Mutilation (FGM): Congress approved legislation requiring the Secretary of State to determine the prevalence of the practice of FGM and the existence and enforcement of laws prohibiting this practice (November 2000). The provision was included in the FY2001 foreign operations appropriations bill (H.R. 4811).

Global HIV/AIDS Prevention: Congress approved legislation (H.R. 3519) to combat the HIV/AIDS epidemic in Africa and around the world. The legislation authorizes \$150 million for an HIV/AIDS trust fund under the auspices of the World Bank in FY2001 and 2002 (August 2000). Additionally, the FY2001 foreign operations appropriations bill (H.R. 4811) included \$315 million for global HIV/AIDS prevention and treatment (November 2000).

Health Insurance Coverage: Negotiators on the Medicare "givebacks" legislation did not include a House Commerce Committee provision that would have allowed states to provide optional coverage under Medicaid and the State Children's Health Insurance Program for pregnant women and children who have been lawfully residing in the United States for two years (December 2000).

HIV/AIDS Treatment and Services: Congress approved legislation (H.R. 4807/S. 2311) reauthorizing and expanding the Ryan White CARE Act (October 2000). Under the FY2001 Labor, Health and Human Services, and Education appropriations bill, the Act received \$1.8 billion in FY2001, an increase of \$213 million over FY2000 (December 2000).

**HPV:** Congress approved legislation requiring the Centers for Disease Control and Prevention to conduct surveillance on human papillomavirus (HPV), as well as a public education campaign. The legislation also requires the Department of Health and Human Services to study whether current condom labels are medically accurate. The provisions were included in the FY2001

Labor, Health and Human Services, and Education appropriations bill (December 2000).

Innocent Child Protection Act: The House approved a bill (H.R. 4888) that would have made it a federal crime to carry out a death sentence on a pregnant woman (July 2000). The Senate did not consider a similar bill.

International Family Planning: Congress approved the FY2000 omnibus appropriations bill with an abortion-related restriction on international family planning programs (November 1999). The restriction denied U.S funds to family planning organizations that use their own money to perform abortions abroad or to lobby foreign governments on abortion. The President waived the restriction, which reduced the total funding for international family planning programs by 3 percent. As a result, the programs received \$372 million, instead of the \$385 million appropriated.

The FY 2001 foreign operations appropriations bill did not include a similar restriction (November 2000). Additionally, funding for international family planning programs was increased by \$40 million to \$425 million. However, the money will not be released until February 15, 2001, giving the next President the opportunity to decide whether to impose additional restrictions.

**Long-term Care Insurance:** Congress approved legislation (H.R. 4040) allowing federal and military employees and retirees to purchase long-term care insurance at group rates (September 2000).

**Lupus:** Congress approved legislation (H.R. 762) to intensify and expand research on lupus at the National Institutes of Health (November 2000). The measure was included in a health research omnibus package (H.R. 2498).

# **Mammography Reimbursement under Medicare:**

Congress approved legislation to increase the payment limit for new technologies for screening mammography under Medicare (December 2000). The provision was included in the FY2001 Consolidated Appropriations Act.

Maternal and Child Health Block Grant (MCHBG): Congress approved legislation to increase

the authorization for the MCHBG from \$705 million to \$850 million (December 2000). The provision was included in the FY2001 Consolidated Appropriations Act. The MCHBG received \$714 million in FY2001 under the FY2001 Labor, Health and Human Services, and Education spending bill.

Medicare "Givebacks": Congress approved legislation to increase Medicare payments to health care providers (December 2000). The legislation includes several provisions related to women's health, including Medicare coverage for biennial screening Pap smears and pelvic exams and increased payment for digital mammography. The measure was incorporated into the FY2001 Consolidated Appropriations Act.

Minority Health: Congress approved legislation (S. 1880/H.R. 3250) to address the disparities among minorities, women, and underserved populations by creating a National Center on Minority Health and Health Disparities at the National Institutes of Health (November 2000). The center was appropriated \$130.2 million in FY2001 under the FY2001 Labor, Health and Human Services, and Education spending bill.

Congress also approved legislation to establish cancer prevention and treatment demonstration projects for racial and ethnic minorities. Additionally, the bill expands the Medicare+Choice quality assurance program to include a separate focus on racial and ethnic minorities. The provisions were included in the FY2001 Consolidated Appropriations Act (December 2000).

**Multiple Sclerosis:** Both the House (October 2000) and the Senate (December 2000) approved a resolution (H. Con. Res. 271) urging increased awareness of multiple sclerosis.

**NIH Funding:** In FY2000, the NIH received \$17.9 billion, an increase of approximately \$2.3 billion over FY1999 (November 1999). In FY2001, the NIH received \$20.3 billion (December 2000).

**Nutritional Therapy Services under Medicare:** Congress approved legislation to extend Medicare coverage for medical nutritional therapy services for beneficiaries with diabetes and renal disease (December 2000). The provision was included in the FY2001 Consolidated Appropriations Act.

**Obstetricians-Gynecologists Access:** Both the Senate (July 1999) and the House (October 1999) approved patient protection legislation (H.R. 2990/S. 1344) that included a provision to guarantee patient access to obgyns; however, the bill stalled in a House-Senate conference (December 2000).

**Osteoporosis:** Congress approved legislation to appropriate \$4 million in FY2000 and \$6 million in FY2001 for osteoporosis research at the Department of Defense (October 1999/August 2000).

**Ovarian Cancer Research:** Congress approved legislation to appropriate \$12 million in FY2000 and FY2001 for ovarian cancer research at the Department of Defense (October 1999/August 2000).

Congress also approved legislation (H.R. 1654) to reauthorize the National Aeronautics and Space Administration. The bill includes \$2 million for research and early detection systems for breast and ovarian cancer and other women's health issues (September 2000).

**Pap Smear Screening under Medicare:** Congress approved legislation to provide biennial coverage for screening Pap smears and pelvic exams under Medicare (December 2000). The provision was included in the FY2001 Consolidated Appropriations Act.

Partial-Birth Abortion Ban Act: Both the Senate (October 1999) and House (April 2000) approved legislation (S. 1629/H.R. 3660) that would have banned an abortion procedure bill supporters refer to as "partial-birth" abortion. However, the measures were not conferenced and sent to the President after the U.S. Supreme Court ruled that a similar state bill was unconstitutional (June 2000).

The Senate also approved an amendment to the "partial-birth" abortion legislation that expressed the sense of the Congress that *Roe v. Wade* should not be overturned (October 1999). The vote was the first time since the U.S. Supreme Court decision in 1973 that the Senate conducted a clear vote on the merits of the decision.

**Patients' Bill of Rights:** The Senate (July 1999) and the House (October 1999) passed patients' bill of rights legislation (H.R. 2990/S. 1344) that included several

provisions benefiting women; however, the bill stalled in a House-Senate conference (December 2000).

**Prescription Drug Coverage:** The House approved legislation (H.R. 4680) that would have provided a prescription drug benefit for seniors (June 2000). The Senate did not consider a similar bill.

Safe Motherhood Monitoring: Congress approved legislation to establish a national surveillance and safe motherhood monitoring program at the Centers for Disease Control and Prevention (CDC). The provision was included in a bill (H.R. 4365) to reauthorize and extend children's health research programs (October 2000). The CDC received \$14 million for the program in FY2001 under the FY2001 Labor, Health and Human Services, and Education spending bill.

**Sex Offenders/HIV Testing:** The House approved a bill (H.R. 3088) that would have required states to allow survivors of sexual assault to request that the alleged assailant be tested for HIV (October 2000). The Senate did not consider a similar bill.

**Substance Abuse and Mental Health Services Administration (SAMHSA):** Congress approved legislation to reauthorize SAMHSA (October 2000). The measure was included in a bill (H.R. 4365) to reauthorize and extend children's health research programs.

**Title X:** Funding for the nation's family planning program received a \$24 million increase to \$239 million under the FY2000 omnibus appropriations bill (November 1999). Title X received \$253.9 million under the FY2001 Labor, Health and Human Services, and Education appropriations bill (December 2000).

Transitional Medicaid Assistance (TMA) Program: Congress approved legislation to extend the TMA program, which was created to help families transition from welfare-to-work by extending Medicaid coverage for up to one year as the families make the transition (December 2000). The provision was included in the FY2001 Consolidated Appropriations Act.

Unborn Victims of Violence Act: The House passed a bill (H.R. 2436) that would have created a separate offense if an individual kills or injures an "unborn child" while committing a federal crime against a pregnant woman (September 1999). The Senate did not consider a similar measure.

United Nations Population Fund: Congress approved legislation appropriating \$25 million for UNFPA in each of FY2000 and FY2001 after funding for the program was eliminated in FY1999. The provisions were included in the FY2000 omnibus spending bill (November 1999) and the FY2001 foreign operations spending bill (November 2000). Funding for the program also was authorized under the FY2000 State Department authorization bill, which was included in the FY2000 omnibus spending bill (November 1999).

Veterans' Sexual Trauma Counseling: Congress approved legislation (H.R. 2116) to expand veterans' access to health care and to reform the Veterans Affairs health care system. The measure contains a provision to reauthorize through December 31, 2002, a VA program that provides counseling and medical treatment to veterans who have been sexually harassed or assault (November 1999).

Women Veterans Special Compensation: Congress approved legislation (H.R. 4850) to make women veterans eligible for a special monthly compensation award for the service-connected loss of one or both breasts, including a loss due to mastectomy (November 2000).
