



Congressional Fellowships on Women and Public Policy | Class of 2020

APPLICATION FORM

Deadline: June 3, 2019

The program is open to applicants who are currently enrolled in, or have recently completed, a graduate program leading to a degree.

The Congressional Fellowships on Women and Public Policy program places current or recent graduate students in the Washington, D.C. offices of Members of Congress and congressional committees. Fellows work 40 hours per week from January through July as legislative aides. Following a mandatory two-week orientation to Capitol Hill in January, Fellows meet once a week at issue seminars with women's advocates, congressional staff, researchers, and lobbyists. WCPI expects to award at least four Fellowships for 2020.

In recent years, Fellowships have been made possible by PepsiCo, Mylan, Amgen, Newcomb College Institute of Tulane University, and the Kahn Education Foundation, and Kaplan, among others.

For 2020, Fellows will receive a stipend of approximately \$3,400 per month gross. An additional sum of up to \$1,000 is provided for the purchase of health insurance with submission of a bill from a provider. WCPI is **not** responsible for funding transportation to and from Washington, or for finding lodging for students. It is up to the Fellow to make all arrangements for satisfying her institution's academic requirements.

PURPOSE

The program is designed to:

- Develop a cadre of talented women experienced in public policymaking at the national level;
- Encourage more effective participation by women in policy formation at all levels of government;
- Examine how policies affect women and men differently and encourage the formulation of policy options that recognize the needs of all people;
- Promote activities that encourage the translation of research into policy;
- Raise awareness that domestic and international issues affecting women are interdependent;
- Increase understanding that those issues often defined as "women's issues" are, in fact, "human issues" of equal importance to men and women.

PROGRAM

Orientation and placement: An intensive two-week orientation program for all Fellows begins in early January 2020 in Washington, D.C. Attendance at orientation is mandatory for all Fellows with **no exceptions**. During orientation, Fellows interview for House and Senate assignments. Fellows are generally placed in their Hill offices by late January; they work through July 2020. Required weekly meetings continue through the course of the program. Fellows are granted seven days of vacation that can be taken at any time with approval of the congressional office and notification to WCPI.

ELIGIBILITY

Only students who are currently enrolled in a master's, doctoral, or professional degree program at an accredited institution in the United States, or who have completed such a program within the past two years, are eligible. You must be legally eligible to work in the United States.

WCPI **strongly recommends** that applicants have completed ***at least nine hours of graduate coursework before applying***, and have a demonstrated interest in research or political activity relevant to issues of interest to women and their families. Applicants often include attorneys, doctors, MBAs, and PhD candidates with extensive professional and volunteer experience. SELECTION CRITERIA

Fellows are selected on the basis of academic competence, as well as demonstrated interest in the public policy process. They are expected to be articulate and adaptable, and to have strong writing skills. Applicants with a variety of traditional and non-traditional academic backgrounds will be considered.

WCPI promotes equal opportunity in its Fellowship program and welcomes qualified applicants of any age, gender, race, religion, sexual orientation, experience, political affiliation, and academic field.

APPLICATION DEADLINE

Applications must be received at WCPI **no later than close of business (5 p.m. Eastern) Monday, June 3, 2019** via regular mail or e-mail. Faxed applications will **not** be considered. Semi-finalists will be interviewed in June and July. Awards will be announced in early August.

As the June deadline approaches, we will notify you by e-mail that (1) your application has been received and (2) what, if any, materials are missing from your application.
