WCPI Recognizes the New Leadership of the Women's Caucus

This year, we welcomed the new leadership of the Bipartisan Women's Caucus (BWC) during an in-person event at the Capitol.



On February 11, outgoing Co-Chairs, Congresswomen Kat Cammack (R-FL) and Susie Lee (D-NV), passed the gavel to Congresswomen Monica De La Cruz (R-TX) and Emilia Strong Sykes (D-OH), Co-Chairs for the 119th Congress. Incoming Vice-Chairs, Congresswomen Nicole Malliotakis (R-NY) and Janelle Bynum (D-OR), participated in the event, and we were also joined by a bipartisan group of congresswomen to celebrate this occasion.



The Bipartisan Women's Caucus Outlines Shared Agenda for Women and Families

Republicans and Democrats Unite to Set Agenda for the 119th Congress

On May 27, the Bipartisan Women's Caucus (BWC) announced their shared policy goals, which reaffirm the Caucus' commitment to championing policies that support the health, economic stability, safety, and leadership of women and girls across the country.

Co-Chairs, Congresswoman Monica De La Cruz (R-TX) and Congresswoman Emilia Strong Sykes (D-OH), along with Vice-Chairs, Congresswoman Nicole Malliotakis (R-NY) and Congresswoman Janelle Bynum (D-OR), presented a collective vision to strengthen and support women and their families through common sense and bipartisan solutions.

The Caucus outlined the following legislation priorities for this Congress:

- Caregiving: Exploring ways to better support caregivers
- Food and Nutrition: Expanding access to healthy and nutritious food
- Small Business and Entrepreneurship: Promoting programs for women-owned businesses
- STEM/STEAM: Creating greater opportunities and a pipeline for women and girls
- Women Veterans: Addressing military sexual trauma and enhancing research on women veterans' health
- Violence Against Women: Supporting efforts to promote the economic security of survivors
- Women's Health: Strengthening and funding maternal health, mid-life health and expanding IVF insurance coverage
- Women's History Museum: Ensuring women's contributions throughout our country's history is recognized and honored

On Wednesday, April 9, WCPI proudly celebrated its 30th anniversary of advancing bipartisan leadership for women and girls in DC. Our 2025 Annual Congressional Gala Reception marked this milestone by honoring the organization's legacy and the women serving in the 119th Congress.

As part of the program, we recognized Dr. Susan F. Wood, a founding board member of WCPI, whose vision and early leadership helped shape the organization's bipartisan mission, and former Congresswoman Nita Lowey, a trailblazing legislator and longtime champion of women and girls in Congress, as well as an early supporter of WCPI's work.

We also honored Cindy Hall, who led WCPI as president for 26 years, and welcomed and celebrated Jennifer Lockwood-Shabat as WCPI's new president, marking the beginning of an exciting new chapter in the organization's history.

We were honored to host 200 guests, including high-ranking administration and federal agency officials, corporate and labor supporters, senior congressional staff, leaders from national women's organizations, and individual supporters who purchased tickets to join us.

Cindy Hall Retires After 26 Years at WCPI



This year, Cindy Hall retired on January 17 after 26 years as President of WCPI. Not only has Cindy been a transformational leader of WCPI, but she's also been an incredible mentor to hundreds of women building public policy careers. She successfully moved WCPI's mission forward by designing programs and partnerships to inform critical legislative issues impacting women while cultivating strong bipartisan relationships among Congresswomen and women congressional staff.

Cindy has served as WCPI's president since 1999, coming on board four years after its founding in 1995. She previously worked for four Members of Congress for more than 17 years, including 12 years as Legislative Director to Ambassador and former Rep. Connie Morella, whose bipartisan leadership was instrumental in landmark achievements for women and girls. Under Cindy's leadership, WCPI underwent significant transformations, adding new initiatives and updating longstanding programs to better meet its mission.

"For more than 25 years, it has been my privilege to work with WCPI's Board of Directors and staff, the Bipartisan Women's Caucus, our bicameral group of women chiefs of staff, our congressional fellows, and our many supporters," said Hall. "While I will miss each of you and our critical work, it is time for a new generation of leadership."



WCPI Remembers the Life and Legacy of Dr. Susan Wood and Former Rep. Nita Lowey

This year saw the passing of two of WCPI's founding Board Members, former Congresswoman Nita Lowey and Dr. Susan Wood.



Congresswoman Nita Lowey served for 32 years in the House and was the first woman to chair the powerful House Appropriations Committee. She was a champion for women's issues and women's health, in particular, and was a tremendous supporter of WCPI, encouraging former Caucus staff to start the organization back in 1995. She remained a steadfast supporter of WCPI's mission for three decades. Beyond her legislative accomplishments, Congresswoman Lowey was an advocate for bipartisan collaboration and mentorship of women in public service. As a founding Board Member and former Co-Chair of the Congressional Caucus on Women's Issues, her leadership helped lay the foundation for WCPI's continued work to advance bipartisan dialogue and strengthen women's representation in policy.

Dr. Susan Wood served as the Deputy Director of the Congressional Caucus for Women's Issues (now the Bipartisan Women's Caucus) and partnered with Marjorie Sims and Lesley Primer Persily to found WCPI. Susan's career was dedicated to improving women's health. She served as the Director for Policy and Program Development in the Office on Women's Health, the Food and Drug Administration (FDA) Assistant Commissioner for Women's Health, and Director of the FDA Office of Women's Health. Susan later became a professor in the Departments of Health Policy & Management and Environmental and Occupational Health at The George Washington University and directed the Jacobs Institute of Women's Health.

The leadership of Congresswoman Lowey and Dr. Susan Wood lives on in WCPI's work, particularly through our work to support bipartisan congressional staff.

Joint Session: Congressional Women Chiefs of Staff & Legislative Directors



We continued our support for women chiefs of staff and committee staff directors in Congress as part of our [Joint Session](#) program, first established by longtime former chief of staff, Betsy Wright Hawkings, in 2015. The program fosters bicameral, bipartisan personal relationships across party lines, builds a support network for women chiefs of staff, committee staff directors, and senior leadership staff, and develops bipartisan women's leadership.



This year, we piloted an expansion of the Chiefs Program to a small group of bipartisan women legislative directors. The launch of this new program was delayed due to the government shutdown but kicked off in December with guest speakers and an opportunity for participants to build relationships across the aisle.



Take Our Daughters to Congress Day



In July, WCPI continued its longstanding relationship with Girls Inc. to collaborate and host an in-person Take Our Daughters to Congress Day, a program we have sponsored for almost twenty years.

Young women from across the country had the opportunity to shadow Senators and their staff, witnessing firsthand what it takes to lead in public service. We're deeply grateful to the Senators and staff who welcomed the girls into their offices and shared their time, stories, and inspiration.

After the event, WCPI and Girls Inc. hosted a lunch for the girls in the U.S. Capitol, where the girls discussed their experiences meeting with Senators and their staff and the lessons they learned from attending this event.
